HERE IS MY TESTIMONY:

Good afternoon, my name is John Strassenburgh and I live in Talkeetna, and have lived in Alaska for nearly 50 years.

I object to use of scarce dollars, in this case \$35 million, to fund pre-construction costs of the proposed Ambler Road.

The FEIS was released yesterday, March 26 and there isn't even a Record of Decision, and BLM won't be issuing one for at least 30 days.

A lot can happen in 30 days, including potential legal action that could tie the project up for some time.

You are jumping the gun. I don't understand this exceedingly compressed time frame, which doesn't provide for due process and meaningful public participation, doesn't consider the contents and recommendations of the FEIS or Record of Decision, or the extent (if any) that the FEIS reflects the public's concerns about the DEIS.

AIDEA is rushing ahead to dedicate funds for this project prematurely and without consideration of the state's stressed budget circumstances and the many other compelling budget priorities.

Top of the priority list is the COVID19 calamity.

The state is going to need every dollar to support public health.. to save lives! And to support small business and laid off employees. And to support tourism and the many businesses that cater to in-state, out-of-state, and international tourists. All are compelling needs.

And yet, your Resolution G20-11, resolves to dedicate \$35 million to fund pre-construction costs for the Ambler Road adventure.

I am 73 years old. I don't want Ambler Road. I want ventilators. I want there to be plenty of ventilators, and test kits, and masks, and gowns and gloves. I want small business and laid off workers to be supported. I want people affected by COVID19 to be made whole for medical expenses, including testing.

It is a blatant corporate welfare proposal, and in any rational world, it would have been Dead On Arrival.

It is absolutely unconscionable that AIDEA would even consider these project in the midst of this unprecedented COVID pandemic. Indeed, it is unbelievable and outrageous. In such times like these, we see both the best and worst of humanity. This AIDEA process (which is likely illegal) is some of the worst, and with respect, you should be ashamed of yourselves.

I work as an environmental data scientist but this comment is on my own behalf.

There are many issues with the proposed road to Ambler including lack of public or local support, unresolved issues regarding the public/private road classification, and inappropriate use of funds without a clear benefit to Alaskans.

I am most qualified to evaluate the environmental assessment, which I deem inadequate. The east-west proposed alternatives (A and B) cut through a single ecologic zone which will have significant impact on all species within that zone and those species crossing through that zone (e.g., caribou and fish migration). These environmental impacts are not sufficiently discussed in the proposals. Alternative C would help distribute the impact over multiple ecologic zones, but at twice the length and expense of the other proposals, C is not viable.

I've been trying to get through on the conference call line referenced on the agenda. All circuits are busy so here is a summary of my comments.

- 1) My names is Lee Hart, I'm an Alaska resident living in Juneau.
- 2) My comments have nothing to do with the details of the Ambler Road project itself.
- 3) I'm told AIDEA is the agency to turn to for "access to capital." I work in the outdoor recreation industry which accounts for 1 in 10 jobs in Alaska. Most of our companies are small businesses well under 500 employees and many are family run, independent businesses who are in desperate need for access to capital right now as businesses are closed due to public health mandates and the tourism industry has the rug pulled out from under it.
- 4) I can't imagine any coronavirus impacts to a road that isn't even approved or built yet that exceed the need of Alaska's many small businesses, including my own, to access capital to stay afloat as we weather the impacts of the coronavirus crisis.
- 5) If we're going to invest \$35 million into something, invest it into our people who need it now. Let's have a more measured conversation about how best to invest \$35 million for the greatest good. Anything less, is not

just tone deaf but literally deaf and blind to the realities of what is going on at this very moment across our state.

My name is JIM MAGDANZ. I lived in Northwest Alaska — in Shungnak, Nome, and Kotzebue — for more than 30 years. I spent most of my professional life in public service. I am retired now, and studying natural resources at UAF. I am speaking today for myself.

For the record, I OPPOSE resolution G20-11

There are many good reasons for AIDEA to be concerned about the economic impacts of the COVID-19 pandemic. But Resolution G20-11 is not about helping the businesses and workers who are being hurt by this pandemic.

Given the circumstances, adopting Resolution G20-8 and G20-11, in combination, would make it appear that AIDEA is using the COVID-19 pandemic as cover to write itself a blank check to advance one of Alaska's most controversial infrastructure proposals. That's not a good look.

Last September, at the first public hearing for the Ambler Road Draft EIS, your spokesperson, Karsten Rodvik, told the Anchorage Daily News that AIDEA would NOT help pay for the Ambler Road without a commitment from mining companies that they will repay the costs. If not a single mining company has committed, then why does AIDEA SUDDENLY need access to \$35 million dollars of public funds?

This action is completely inconsistent with AIDEA's previous messaging – namely that industry will foot the bill. If that is no longer true – if in fact Alaska taxpayers will be footing the bill for this road on top of every other terrible economic need that Alaska faces today – then AIDEA should be transparent about that.

In 30 years of public service, I have never seen a public body in Alaska – save perhaps the Legislature itself – attempt to allocate such a large sum of public money with such little notice. This is not how the public's business should be done. This is not when this particular piece of public business – funding Ambler Road development – should be done.

I urge each of you to vote NO on Resolution G20-11. Thank You.

Sherrie,

Mr. Pruhs and Mr. Boutin previously refused my previous respectful request to allow the public to have an agenda item to allow the public to address the AIDEA Board on the Ambler Road (according to your prior email.) As you can see, there is significant public interest in this issue – which AIDEA has refused to hear. The public cannot even contact the AIDEA Board members individually, according to you.

Now Chairman Pruhs has changed the public's ability to testify twice in today's (3/27) meeting: first limiting it to a specific item, then limiting to 2 minutes; then again changing the rules to open it up to all comments. Consequently, I was not allowed to provide my comment on the Ambler Road issue, and confined my remarks, as requested to G20-08.

First The Board violated the Opens Meetings Act AS AS 44.62.310.

Gov Dunleavy's guidance on special meeting states: "Special meetings should be held rarely and only to address time sensitive issues." COVID-19 is certainly time-sensitive, but there is nothing time-sensitive about the \$35 million funding proposed for the Ambler Road Resolution G20-11. It is unlawful to address that in a special meeting.

Second, The Board violated its own regulations at 3 AAC 99.920 and bylaws Article II §2 by failing to give 5 days notice of the subject of its meetings. Nothing in the AIDEA online notice issued only 3 days ago indicates the subject of this meeting.

Third, yesterday the Board violated the Open Meetings Law Thursday 3/26 by improperly going into Executive Session without first identifying the specific bases that necessitated Executive Session within the 4 parameters of the Open Meetings Act exceptions - for each topic discussed in Executive Session. There may have been a valid basis due to the COVID-19 emergency – but the Ambler Road is not a COVID-19 emergency.

Fourth, the sleight of hand in the revised Resolution G20-11 which was changed at the last minute, again with no public notice, does not cure the fact that AIDEA is running afoul of the Alaska Legislature's authority to make decisions about how state funds will be allocated. As the legal analysis in testimony Thursday cogently outlined, this violates the Alaska Constitution and the Executive Budget Act.

The AIDEA Board is respectfully requested to withdraw G20-11 and explain to the public why, in this time of COVID-19, that money is not being put into, AIDEA's Small Business Economic Development Fund to aid individuals and small businesses around the state.

AIDEA has funneled money for the Ambler Road through its Economic Development Account and through the Enterprise Development Account (in the **Revolving Fund**) and now proposes to funnel \$35 million for Ambler is the Arctic Infrastructure Development Fund (the **Nonmajor Fund**). I ask the AIDEA Board members examine the AIDEA 2019 *Financial Statement p. 28* describing these funds, and then and please explain to the public what is going on with the helter-skelter movement of money for the Ambler Road between these 3 funds –none of which has been approved by the Legislature for the Ambler Road funding.

Six years ago, the AIDEA meeting minutes for 4/14/2014 AIDEA Board Chair Mr. Pruhs asked if a budget had been prepared for the Ambler Road. The staff responded "there is a budget" and "believes it is approximately \$42

million." The staff committed that the budget "would be provided." That has never been provided despite requests over the past six years. The \$35 million in G20-11 added to the \$17 million AIDEA already spent (according to its website as of 3/4/2020) curiously, adds up to \$42 million with no public AIDEA Board review.

It is requested that AIDEA provide a transparent public budget for the AMDIAR, with adequate public notice, and allow the public to testify at a regularly scheduled agenda once that budget is provided, before approving any further AMDIAR funding.

Thank you for the opportunity to testify.

Alaska Wildlife Alliance is opposed to G20-08 because the conditions of this proposal are far too broad and ambiguous. Jomo Stewart referenced that the Fairbanks Economic Development Corporation requested support that *might* be included in this proposal, but there is no way to know the bounds of this resolution as written. Unlike Mr. Stewart, we **do not** give AIDEA the benefit of the doubt, especially given the abrupt changes AIDEA has made to agendas, public testimony time, edits to resolutions themselves, and emergency meetings called in too short a time for meaningful public participation.

We also oppose G20-11 in an echo of testimony given yesterday and the near *unanimous* testimony given today in opposition to this resolution. Our opposition is outlined as follows:

- Problem with process:
 - o These emergency meetings were called too late and managed in too disorganized a manner, which limits meaningful public participation. Additionally, Chairman Pruhs treatment of the public yesterday, in anger towards AIDEA's own technological limitations, was completely uncalled for, unprofessional, and discouraging to participation in this process. Clearly, the Board does not have the technological capacity to handle a tele-meeting to comprehensively discuss proposals with this many dollars and local stakeholders on the line.
 - o The Board cannot in good faith vote on resolutions in this agenda when public comment has been cut short both yesterday and today.

- Problem with resolution itself:
 - o The FEIS was released yesterday and it verified numerous impacts to wildlife and livelihoods. This is a rushed financial transfer that does not allow small business owners or residents in communities most affected by the project to meaningfully participate in the process. Specifically to speak to FEIS findings that:
 - All action alternatives would result in impacts to vegetation; wetlands; and fish, birds, and mammal habitat. Wetland and vegetation habitat, road dust, noise, movement, and light or shading, and potentially spills of pollutants from truck traffic. Fragment wildlife habitat. Caribou migration patterns and movements of other wildlife could be affected by the presence of a road and road noise. (Page 27)
 - " All action alternatives may significantly restrict subsistence uses for the communities of Alatna, Allakaket, Ambler, Anaktuvuk Pass, Kiana, Kobuk, Selawik, and Shungnak. In addition, Alternatives A and B may significantly restrict subsistence uses for the communities of Bettles, Buckland, Coldfoot, Evansville, Kotzebue, Noatak, Noorvik, and Wiseman." (Page 29)

We are opposed to providing \$35 million to the Arctic Industrial Development Fund to pay for fieldwork, design, and permitting of the Ambler Road. That money should be spent on Alaskan businesses and families who currently need it. Ambler Road, and the multinational corporation interests it serves, does not need this aid. The total cost of building, operating, and maintaining this project is expected to be between \$844.0 and \$906 million. If the mines go bankrupt, the state will be on the hook and shortcutting the process to pour \$35 million more into this risky project is tone deaf to the economic crisis we face. This road is risky investment in any economic situation,

exacerbated by the fact that mining stocks are plummeting *and* we have thousands of small and medium sized business owners who really need this aid.

Finally, in addition to advocating against this transfer of funds to Ambler, I also encourage that state and federal review processes for major infrastructure projects, such as this, be halted. This is an unprecedented time in our history, when people are rightfully concerned about their families' health and other uncertainties caused by the pandemic. This is not the time to move forward with a project as precarious as this one, especially in such a rushed process with limited ability for the public to participate.

Comments for AIDEA emergency meeting 3-27-20

Regarding: Resolution G20-11

Thank you for this opportunity to comment on AIDEA's proposed resolution G20-11 to transfer \$35 million from an Alaska State revolving fund into a fund dedicated to furthering development of the proposed Ambler Road.

I think the proposed \$35 million transfer is foolish and misguided at best. At worst, it is a cynical attempt to expedite an economically problematic and environmentally destructive mining project when all eyes are elsewhere during a time of crisis. Today there is indeed an emergency that AIDEA should be addressing: helping to avoid and mitigate social and economic harm from the Covid-19 pandemic. Sidestepping public and legislative scrutiny of the Ambler Road project is neither an emergency nor appropriate at this time. I would also like to criticize the highly unprofessional and arguably illegal manner in which this public meeting is being held today.

Why, I ask, in the name of decency and prudence and situational awareness would the AIDEA board choose this time of escalating crisis to divert critical funds away from public health needs that we know will grow every day? Why would you fixate on a risky venture with no possibility of near term benefit at the clear expense of many possible ways to bolster local economies and aid struggling Alaskans?

The Ambler Road Project is controversial, with glaring "red flags" pointing to reasons we should not undertake the project at all for economic, social, and certainly environmental reasons. There is staunch local opposition to the project, overwhelming objection by Alaskan and national conservationists, and a glaring history of this type of industry give-away not only not paying the promised dividends to our society at large, but also of haunting future health and well being of the region through boom-bust economic collapse and long-lingering environmental contamination. In short, even the strongest selling point for this project—jobs for Alaskans—is highly problematic: the state may very well end up spending more money

building and maintaining the road than it is able to recoup, and the negative social costs to local communities resulting from the road and the mines will could very well outweigh the positive effects from two or three decades of limited employment. When the risks and costs of perpetual remediation of acid mine drainage are factored in, the proposed road is likely to be one more example of a lingering mining disaster that is anything but beneficial. Far safer, more broadly benign investments in Alaska's economic health abound, and the Covid-19 pandemic begs that you focus on more immediately productive investments.

I urge AIDEA's board members to vote "NO" on this inappropriate proposed transfer to expedite building the Ambler Road. This project has been festering for years, and deserves full scrutiny by the public. This is absolutely not the time or way to allocate millions of scarce Alaskan dollars with minimal public oversight.

I tried to call into the AIDEA special board meeting/teleconference several times on Thursday afternoon and could not get through. I have prior commitments this afternoon (Friday), so will not be able to participate by phone, so I hope you will instead accept these email comments.

I'm a resident of Anchorage and longtime Alaskan who has followed the proposed Ambler Road project for several years. I also have a personal connection to the area that's affected, first as a geologist who worked in the Central and Western Brooks Range in the 1970s, and also someone who has had close ties to the Central Brooks Range and especially Gates of the Arctic National Park & Preserve for several decades, as an adventurer/backcountry traveler, wilderness advocate, and writer.

I am strongly opposed to the resolution that would allow AIDEA to transfer \$35 million from what I understand to be a state revolving fund into a separate fund that would be used to help pay for permitting and pre-construction costs of the Ambler Road project.

To me it is unconscionable and unethical for AIDEA to take money that could be used to help Alaskan businesses impacted by the economic crisis precipitated by the COVID-19 pandemic and transfer it to a fund that can only be used for the Ambler Road project. The money would be much better used to help the many Alaskan businesses that are suffering economic hardships during this time.

It's my understanding that AIDEA is using the pandemic to justify waiving its rules to allow this transfer, which makes that action even more egregiously unacceptable.

My name is Charles Gilbert. I urge the board to disapprove Resolution G-20-11, which would transfer \$35M from an AIDEA revolving fund to the Ambler Road project. I understand that such funds would be used to pay for detailed engineering of the road, engineering of the many bridges that would be required, legal representation and other other consultants. This is a case of "Putting the cart before the horse."

The Ambler Road project is controversial for many reasons, and no decisions have yet been made as to whether such a road will be built. The environmental review process isn't complete, so even decisions on issuance permits have not been made. The economic feasibility of the project has not been determined. AIDEA's successful Red Dog Road is cited as the model to apply to the proposed Ambler Road. But a 200+ mile road to the Ambler Mining District is an entirely different animal than the 52 mile Red Dog Road—a road that follows high ground on rolling hills nearly all the way from the mine to a coastal port, crossing no major waterways. Whereas the Ambler Road would run along 200+ miles of the south flank of the Brooks Range, crossing several large rivers and many, many other waterways, as well as significant wetlands, all at great cost in construction and maintenance of bridges and a sustainable roadbed, and that's just to get to the Haul Road, not to a tidewater port. The ability of the mining companies to pay tolls that would fully reimburse AIDEA for the costs of building, maintaining and removing the road is highly suspect. Yet that feasibly determination has not been made.

To provide the Ambler Road project with \$35M to do detailed road engineering and bridge design, before it's even decided that a road and numerous bridges will be built, is a misuse of dollars that are needed right now on projects critical to Alaska. I urge you to disapprove Resolution G20-11. Thank you for this opportunity to comment.
